

JB – I agree with equal marriage but the Union's opinion is shown at every Union event. If we are to look at each event to see whether it is appropriate, then we would be doing a wishy, washy job. If we do it, we should go for it.

SB - I am still in favour of the motion and if it doesn't go through we will have to wait another three weeks before the mandate is re-issued.

CR – If we put the flag up when it is appropriate then it still leaves the option that the flag wouldn't be put up.

TW – I support equal rights but the Union needs to work on not alienating groups / minorities or people.

DMcE – We need to appreciate that at some events putting up the flag would be deemed inappropriate.

9a was called on the motion.

Chair – All in favour of proposed amended motion please raise their hand?

Motion passed by majority.

Food Labelling

MC – I would like to point out that this motion is not to do with meat products. This motion was brought to Council in order to try and help international students as well as students with different cultures and dietary requirements identify food which they are able to eat in our SU Shops.

Returning Officer - Please let us know if you, or anyone you know would like to put themselves forward for election of the roles left vacant at present.



MC - This will be a three day festival held in week ten of semester one. There will be international dancing, food, film nights etc.


BT - Will this tie in with the international walk?

i. **Budget**

FH gave a brief description surrounding changes which occurred from the previous year.

- **MK** I am struggling to compare last year's figures with this year, I have done ten years in procurement and as there are no actualities included so I can't work out differences.
- **FH** These are simply comparing budgets. We cannot present actual figures until the auditors come in. These figures are naturally going to change as the year progresses. One example is that the 'other income' has already easily surpassed the figures in the budget.
- **Chair -** The annual audited accounts are to be presented before Christmas and FH is aware.
- **TW** Should we not be budgeting for the worst case scenario?
- **FH** This is a prudent budget. It was seen inconsiderate to budget for anything which made a substantial loss the previous year.
